TAX CREDIT MAXIMUMS FOR TAX YEAR 2018

Go Ahead, Take The Credits!

It's simple! Redirect your tax dollars to AESF!

A school tuition organization (STO) cannot award, restrict or reserve scholarships solely on the basis of donor recommendation. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either tax payer's own dependent. AESF is a qualifying Arizona STO for the purpose of the Arizona State Private School Tuition Credits. Tax ID #86-0973130.

SINGLE, MARRIED FILING SEPARATELY OR HEAD OF HOUSEHOLD

Original Individual Credit \$ 555
Take MORE Credit \$ 552

Total Maximum Tax Credit \$1,107

Or the ACTUAL TAX, whichever is less.

MARRIED OR FILING JOINTLY

Original Individual Credit \$1,110
Take MORE Credit \$1,103

Total Maximum Tax Credit \$2,213

Or the ACTUAL TAX, whichever is less.
